AND WHEREAS, for the convenience of management and development of the aforesaid institutions it was felt that a Trust be formed in accordance with law and the entire properties of the aforesaid schools be vested in the said Trust and accordingly, a Trust was formed under the name and style of 'Marwari Education Foundation' vide the Deed of Trust bearing no. 2064 of 2003 registered on 14.10.2003 w.e.f. 30-06-2003 detailing therein the mode of formation of the Trust, the different types of Trustees and other details of the Trust including the vesting of all the properties of the schools in the said Trust which were described in the Schedule given in the said Deed and the said Trust was thereafter functioning;

AND WHEREAS, one of the original members of the erstwhile Marwari Hindi High School Managing Committee, viz., Bhawani Shankar, Bagaria (since deceased), S/o Late Sardarmal Bagaria, a resident of Dibrugarh also became one of the permanent trustees of the aforesaid Trust;

AND WHEREAS, the said Bhawani Shankar Bagaria who was a man of philanthropic nature with an intention to organise, develop and further the object of the Trust, decided to donate 6 Bighas 0 Katha 0 Lessa of his land situated at Dainijan Gaon, Mouza Mancotta Khanikar, District Dibrugarh, to the Trust for the purpose of construction of a School for imparting education other than only vocational education starting from the Primary level to the High School level/ Higher Secondary Level only and declared his intention to do so among the trustees of the Trust and in pursuance to the said declaration, executed a Deed of Gift being Deed No. 362 of 2006 of Dibrugarh Sub-Registry on 30-06-2006 whereby, said Bhawani Shankar Bagaria gifted that

aforesaid land measuring 6 Bighas 0 Katha 0 Lessa being land of part of Dag No. 91 covered by

Tea Periodic Patta No. 4 (Ka) situated at Dainijan Gaon, Mouza Mancotta Khanikar, District Dibrugarh, which was fully described in the aforesaid Deed of Gift and which gift was accepted by the donee, i.e., the Trust and the said plot of land was lying in the possession of the Trust since then and thus became the property of the Trust together with its other properties;

AND WHEREAS, the aforesaid facts of the donation of 6 Bighas 0 Katha 0 Lessa of land and of the decision of reserving one post of Trustee to be filled up by the lineal descendants of Bhawani Shankar Bagaria (since deceased) from amongst his lineal heirs and successors, descendants remained to be incorporated in the Deed of Trust together with the details of the aforesaid land which was gifted by Late Bhawani Shankar Bagaria to the Trust in the Schedule of the Property mentioned in the Deed of Trust aforesaid;

AND WHEREAS, it was already unanimously resolved in the meeting of the Trustees of the Trust Board which was held on 05-11-2019 and further ratified in the Special General Meeting of the Foundation held on 22-12-2019 that amendments in the original Deed of Trust bearing no. 2064 of 2003 of Dibrugarh Sub-Registry needs to be made so as to record the aforesaid facts and to keep the same alive for the posterity, in-as-much-as, the gift made by Bhawani Shankar Bagaria (since deceased) for the construction/establishment of a School for imparting education other than only vocational education starting from the Primary level to the High School level/ Higher Secondary Level only at Dainijan area at Beheating gives a new dimension in the development of the said project contributing significantly and substantially for advancement of the entire educational atmosphere of Dibrugarh;

AND WHEREAS, it was also felt that with the incorporation of the aforesaid provision some further changes needed to be effected in the original rules and regulations of the Trust for which, vide the aforesaid resolution dated 05-11-2019 adopted in the meeting of the Trust and further ratified in the Special General Meeting of the Foundation held on 22-12-2019, it was

NOW THEREFORE IN VIEW OF THE AFORESAID FACTS, THIS DEED OF AMENDMENT is executed today stating the aforesaid facts which needs to be incorporated in the original Deed of Trust bearing no. 2064 of 2003 wherever required and for that purpose this Deed may be read after Clause No. 25 of the original Deed of Trust and these amendments be deemed to be included/effective therein w.e.f 22-12-2019 and both the original Deed of Trust effective from 30-06-2003 and this Amended Deed of Trust be treated as one and single document and the amended rules and regulations shall be deemed to be automatically amended and the new amended rules shall come into operation w.e.f 22-12-2019;

It is also clarified that the Schedule which has been given in the original Deed of Trust is also hereby amended by adding Point No. 7 and also by incorporating all immovable and movable properties embedded or standing on the piece and parcel of land described infra as on the date of execution of Original trust Deed as follows:
